NOTIFICATION

Whereas a large number of requests for issue of new permit in different new Stage Carriage Route have been received by the Regional Transport Authority, North 24 Parganas.

And whereas there is no direct/easy communication between starting and terminating point of the proposed route, and whereas the endeavor of the Government to augment the passenger transport service for the interest of public demand and recommended by local representative.

Now, therefore the Regional Transport Authority, North 24 Parganas in its meeting on different dates mentioned against each category pondered over this issue and decided to create the following stage carriage routes (**Bus**) in exercise of power conferred vide section 68(3) of the M.V. Act read with Notification No. 4111-WT/3M-88/2003 dated 14-11-2013 and 509, STA/SC/7E-362/2014, dated 10-07-2014 issued by the Secretary, STA in the manner as given bellow, only to be filled up for operation of services by way of public notice to be published widely.

1. Terminal facilities for the routes, thus created, are to be ensured before granting permits of the aforesaid routes.
2. Seating capacity to be identical for Stage Carriage Buses of a particular nature of service for any particular routes have been fixed at 39 to 42 & above Seats. RTA, North 24 Parganas shall be the competent authority to issue permits for all this routes.

This will come into immediate effect.
