Whereas a large number of requests for issue of new permit in different new Stage Carriage Route have been received by the Regional Transport Authority, North 24 Parganas.

And whereas there is no direct/easy communication between starting and terminating point of the proposed route, and whereas the endeavor of the Government to augment the passenger transport service for the interest of public demand and recommended by local representative.

Now, therefore the Regional Transport Authority, North 24 Parganas in its meeting on different dates mentioned against each category pondered over this issue and decided to create the following stage carriage routes (Maxi Cab) in exercise of power conferred vide section 68(3) of the M.V. Act read with Notification No. 4111-WT/3M-88/2003 dated 14-11-2013 and 509, STA/SC/7E-362/2014, dated 10-07-2014 issued by the Secretary, STA in the manner as given bellow, only to be filled up for operation of services by way of public notice to be published widely.
