

  - "Act" means the Essential Commodities Act, 1955 (10 of 1955);

- f) "Collector" has the same meaning as in clause (ia) of section 2 of the Essential Commodities Act, 1955 (10 of 1955);
- g) "Consumer" means a person whose name is registered with a dealer for getting supply of cooking gas from that dealer;
- h) "Cooking gas" means liquefied petroleum gas bottled in cylinder of a specified weight defined by OMC;
- "Dealer" means a person including a firm, an association of persons, a company, a corporation, a partnership firm or a co-operative society engaged in the business of purchase, sale or storage for sale, of cooking gas, on the basis of an agreement with an Oil Marketing Company, whether or not in conjunction with any other business, and includes his representative, employee, agent or commission agent but does not include an Oil Marketing Company;
- j) "Director" means the Director of Consumer Goods, (DCG) Department of Food and Supplies, Government of West Bengal and includes an Officer not below the rank of Assistant Director in the said Directorate authorized by the said Director in writing to perform all or any of the functions of the Director under this Order;
- W) "District Magistrate" in relation to a district means the District Magistrate and includes Additional District Magistrate in charge of Food Affairs, Sub Divisional Officer, District Controller of Food and Supplies and Sub Divisional Controller of Food and Supplies as the case may be, who has been delegated in writing to perform all or any of the functions of District Magistrate under this Order by the District Magistrate;
- (m) "Form" means a form appended to this Order'
- (11) "Licensee" means a person holding a valid licence granted under this Order;
- (e) "Licensing Authority" means (i) the Director of Consumer Goods(DCG) in case of a Dealer in Cooking Gas within Kolkata and Bidhan Nagar area and (ii) the District Magistrate in case of Dealer in Cooking Gas within a district under his/her jurisdiction;
- (p) 'Monitoring / Vigilance Committees' shall mean and include a Committee or Committees constituted from time to time by the State Government;
- (q) 'Notification' means notification published in the Official Gazette;
- (r) "Oil Marketing Company" means any of the following oil companies:
  - (1) Indian Oil Corporation,
  - (2) Hindustan Petroleum Corporation.
  - (3) Bharat Petroleum Corporation,
- (s) "State Government" means the Government of West Bengal in the Department of Food and Supplies.
- (t) "Vigilance Squad" means squad formed by the State Government or by the Director of Consumer Goods or by other Licensing Authority for the purpose of close surveillance over the functioning of Cooking Gas Dealers.
- (u) "Year" means a year reckoned according to the English calendar.

- (iv) The licensing authority will cause inspection at the office of the Dealer at any time as a normal supervision measure or on the basis of public complaint, during which the Books of Accounts and other relevant documents as may be specified by the Licensing Authority will be inspected, provided that the State Government shall have authority through officials not below the rank of Sub Inspector of the Department of Food and Supplies to conduct Inspection or call for any documents maintained by the Dealer.
- (v) Every Dealer shall abide by the instruction as may be issued from time to time by the Licensing Authority of the State Government.
- (vii) The licensee shall comply with the provisions of the West Bengal Cooking Gas Control Order 1985, as amended, as well as with the directions issued by the Director of Consumer Goods or the District Magistrate as the case may be, from time to time.

# CONDITIONS

- 1. The licensee shall not enter into any transaction involving purchase, sale, or storage for sale, of cooking gas in a speculative manner prejudicial to the maintenance and easy availability of supplies thereof in the market.
- 2. The licensee shall not withhold from sale/supplies cooking gas ordinarily kept for sale.
- 3. The licensee shall give all facilities at all reasonable hours to the Licensing Authority or any officer authorised by it or the State Government for the inspection of his stocks and accounts at any shop or other place used by him/her for storage, sale, or purchase of, cooking gas.
- 4. The licensee shall comply with any directions that may be given to him from time to time by the Licensing Authority in regard to the purchase, sale, or storage for sale, of cooking gas and in regard to the manner and the language in which the accounts shall be written.
- 6. The license shall cease to be valid in the event of death of the licensee or death of one of the partners in case the licensee is a partnership firm, or transfer of interest of the licensee in his/her business under license or reconstitution of the partnership firm where such firm is a licensee.
- 7. If the licensee intends to change his place of business to, or to store cooking gas in, any place or premises other than those mentioned in the licensee, the licensee shall surrender the licensee and apply for fresh licensee in the new place.
- 8. The licensee shall issue to every customer a cash memo, or credit note, as the case may be, giving its name, license number and address, the date of transaction, the quantity sold, the price, the number and date of the permit, if any, under which sold and the salesman's signature and shall keep duplicate carbon copies and credit notes, if issued manually or if electronically issued, shall keep backup in computers used in the business place, arranged serially and chronologically to be made available for inspection on demand by the Licensing Authority, or any officer authorised by it in writing in this behalf, and shall also preserve such duplicate copies or backup in compact disks for one year from the date of issue.
- 9. The licensee shall sell correct quantity of cooking gas with the help of accurate measuring instruments certified by the appropriate authority and calibrated on quarterly basis regularly.
- 10. The licensee shall comply with the provisions of the West Bengal Cooking Gas(Licensing and Control) Order, 1985 as well as with the directions issued by the Director of Consumer Goods or District Magistrate, as the case may be, from time to time. In no circumstances, ignorance of the West Bengal Cooking Gas(Licensing and Control) Order, 1985 shall be valid ground for escaping penal measure.
