No 920/FES/O/3S-33/2016 (Pt. -I) , Dated 25<sup>th</sup> day of June, 2018. In exercise of the power conferred by sub-section (2) of section 10, section 12, section 13, section 14, sub-section (2) and sub-section (5) of section 15, section 18, section 19 and section 38, read with clause (aa), clause (b), clause (cc), clause (h) and clause (i) of sub-section (2) of section 40 of the West Bengal Fire Services Act, 1950 (West Ben. Act XVIII of 1950), the Governor has been pleased hereby to make the following amendments in the West Bengal Fire Services (Fire License) Rules, 2004, as amended and issued with this Department Notification No. 1733/FES/O/3S-33/2016, dated the 30<sup>th</sup> August, 2017 and published in the *Kolkata Gazette, Extraordinary*, Part I, dated the 31<sup>st</sup> August, 2017 (hereinafter referred to as the said rules).
