ORDER

Whereas Authorized Officer, Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 02-0360, Action area ID, New Town, P.O-Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Borrower & Guarantor namely Md Azizul Haque S/O Mohd Islam Mondal; Siratun Necha Bibi, W/O- Md Azizul Haque, residing at Vill- Sikra, Hishabi, Sikra, Awalsidhi ,Amdanga , North 24 Parganas, Pin-743221 (Case No-736/22) dated 23.08.2022

whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 02-0360, Action area ID, New Town, P.O-Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor granted a loan Rs. 5,00,000.00 (Rupees Five Lac) Only on 11.10.2018 to Borrower & Guarantor namely Sri Md Azizul Haque S/O Mohd Islam Mondal, Siratun Necha Bibi W/O- Md. Azizul Haque residing Vill- Sikra, Hishabi, Sikra Awalsidhi, Amdanga, North 24 Parganas, Pin-743221 (against the all the mortgaged piece and parcel of landed property as follows:

SCHEDULE OF PROPERTY

All that piece and parcel of landed property measuring 5.33 Decimals be the same a little more and less, lying and situated at Mouza-Shikhira, Police Station Amdanga J.L.No-28, Touzi no 13, RS and L. R dag No-1320 / 2147, L.R Khatian nos. 1776, District North 24 Parganas. Owned by Md. Azizul Haque, S/O- O Mohd Islam Mondal, virtue of Bengali deed of sale dated 27.05.2014 and corresponding to 12 th Joistha,1421 B.S registered in A.D.S.R - Amdanga, Deed No. - 01427 for the year 2014.

The borrower has committed default in repayment of the financial assistance granted aggregating the specified amount and consequent to such default in repayment, the account of borrower was classified as NPA on 30.01.2021 due

to non servicing of interest/ installment.

- Notice dated 22.09.2021 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs.5,95,827.62 (Rupees Five Lac ninety Five Thousand Eight Hundred Twenty Seven & Sixty Two Paisa) Only. The Demand petice was received by the borrower on 01.10.2021.
- The Authorised Officer of the secured creditor received no representation from the borrowers in reply to demand notice u/s 13(2), dated on 22.09.2021
- The Secured creditor issued possession notice dated 10.03.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 12.03.2022.
- Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor

whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural 8) land

and whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of , Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 02-0360, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 the secured creditor and being satisfied, it is hereby ordered that Sri Lakshmi Kanta Roy, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the District Magistrate, North 24- Parganas, Barasat will take physical possession of the secured assets/property and forward the same to the secured creditor u/s 14 (1A) of SARFAESI act. 2002

Whereas Authorized Officer, of , Ujjivan Small Finance Bank Limited, Eastern Regional Office, Rishi Tech Park, 4th floor, Premises no 02-0360, Action area ID, New Town, P.O – Rajarhat, P.S- New Town (Old Rajarhat), Kol-700160 shall intimate the date of possession of the secured asset to The Superintendent of Police, Barasat. P.D, North 24 - Parganas, as well as to, Sri Lakshmi Kanta Roy, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the District Magistrate, North 24- Parganas, Barasat well in advance to take physical possession of the secured assets/Property of the secured creditor on behalf of District Magistrate, North 24- Parganas, The Superintendent of Police. Barasat P. D, North 24 - Parganas, will provide police force for maintenance of law & order. The secured creditor will remain present at the time of taking over physical possession.

A spot videography should be made in connection with taking over physical possession of secured assets, on the date of taking over possession and soft copy of the videography should be kept under custody. Let copy of this order be served upon all concerned.

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
