whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor granted a loan Rs. 27,50,000.00 (Rupees Twenty Seven Lakhs Fifty Thousand) only on 20.09.2017 to Borrower & Guarantor namely Prabir Kumar Saha, Aparna Saha both are residing at 2/3B, Gopal Chandra Chatterjee Road Cossipore, Kolkata , West Bengal-700002, M/S Fancy Prints ,Kadi Hati ,Bishnupur Road, Narayanpur, Kolkata West Bengal-700132 against the all the mortgaged piece and parcel of landed property as follows:
