## ORDER

An enquiry has been initiated against a possible suspicious and unjustified increase of Digital Ration Card figures among 98 SKO shops under Dum Dum P.S. in June, 2020. In connection to the said enquiry, all volumes of the DRC Register of such SKO shops have been sought for the purpose of verification. But SKO Dealer Sri Suhasish Sarkar (SKO Dealer Code: K233700100741) has failed to produce his DRC Registers (which he claims to have lost) or any conclusive evidence regarding the DRCs linked with his SKO shop.

Therefore, a **"Re-authentication and Re-Registration"** exercise is necessary to identify the SKO beneficiaries assigned to the SKO shop and shall be conducted at the **SKO shop point** of Sri **Suhasish Sarkar** (SKO Dealer Code: K233700100741) at 23/2/31A Dum Dum Mall Road under Dum Dum P.S., PIN: 700080, North 24 Parganas during **the entire distribution cycle of August, 2022**. For the said purpose, a **team** is hereby constituted as delineated below:

1. **Sri Madhusudan Das**, Ins(F&S) - Leader
2. **Sri Biswajit Kumar**, Ins(F&S)
3. **Sri Tapas Mandal**, Ins(F&S)

Before commencing the exercise, this team shall ensure that relevant **notices**, preferably in vernacular, **is displayed** at the SKO shop point concerned, all other nearby SKO shops, local SKO Agent point, all ward offices of municipalities concerned, important points of local markets, etc. for wide publicity of the matter.

**This team shall be responsible for re-authentication of the beneficiaries and reconstruction of the DRC Register of the SKO Dealer concerned.** The sale of PDS SK Oil and the work must be carried out during the official distribution hours in presence of a team member, and a **detailed report along with certified copies of the reconstructed DRC register** is desired from the leader of the team concerned **within a date not later than September 7, 2022**. The officials must adopt all standard procedures in this regard and shall ensure proper execution of the task. This is in the interest of public distribution system.
