Applications are invited from the willing retired Inspectors, BCW/ Extension Officers/ Head Clerks of Blocks/ similar posts (all from B Category service) for engagement as Additional Inspector, BCW, in the office of the District Head Quarter/ Sub-Divisional Offices/ Block Development Offices/ Municipality offices/ Municipal Corporation of this District on contractual basis for a period of 01 (one) year. The consolidated pay would be Rs 12,000/- (Rupees Twelve Thousand) only per month. Willing candidates may submit their applications to the District Magistrate, North 24 Parganas (at the Office of the Project Officer-cum-District Welfare Officer, Backward Classes Welfare, 1 No. Station Road, Rishi Bankim Sarani, Barasat, North 24-Parganas, Kolkata-700 124.) in the format attached with this notice along with documents stated below from 12.09.2019 to 17.09.2019 between 11:00 A.M. to 4:00 P.M. Candidates, who have worked as Inspector, BCW or in the Office of the Block Development Officer/ Sub-Divisional Officer/ P.O.-cum-D.W.O./D.W.O, BCW of a district will be given preference.

1) The candidate must be a retired State Govt. employee in the rank of Inspector, BCW/ Extension Officer/ Head Clerk of Blocks/ similar posts (all from B Category service).

2) Age of candidates should be above 60 years (as on 01.09.2019). Candidates with age above 64 years (as on 01.09.2019) need not to apply.

3) No other financial benefit except the contractual consolidated remuneration of Rs. 12,000/- (Rupees Twelve Thousand) only per month will be admissible to Additional Inspector, BCW engaged on contractual basis.

4) The Additional Inspector, BCW engaged on contractual basis will have to discharge the duties and responsibilities of the Inspector, BCW and any work that may be assigned by the Superior Authority from time to time.
