Description of items required for the fair is 240 nos. stall having 100 sq. ft. in each stall, 15 (Fifteen) nos. food stall having 150 sq. ft. each, 40 nos. of kiosk and other infrastructure arrangement such as 4 nos. of kitchen Shed, pavilion, office room & VIP room with toilet facilities, Samiana in front of stage with sitting arrangement of visitors covering around 29000 sq. ft. of area. Tenderers who have credential certificate of single contract for Rs.15,000/- (Fifteen thousand) only for conducting the same nature of work may only quote rate along with valid ST/VAT, PAN, PTC, Credential Certificate, Fire License Certificate, GST Registration Certificate, Trade Licence, Last three year Income tax return file, Last three year profit & loss statement & balance sheet, Last three year Vat Return certificate to be submitted.
