#### Terms & Conditions (as per corrigendum)

- The bid documents shall be received from 08/12/20 to 15/12/2017 up to 2 pm, Tender Application (Annexure-II) shall be addressed to the Chief Medical Officer of Health & Secretary District Health & Family Welfare Samiti, North 24Parganas, Kolkata-700124.
- 2. Before submission of the tender, Bidder shall sign each page of his/her tender and all its relevant papers with date.
- 3. Tender not submitted as per the format or within the stipulated time shall be summarily rejected.
- 4. Tender received without stipulated EMD shall be summarily rejected
- 5. Bidders must have helpline and dedicated customer support.
- 6. Warranty & CMC:-contractor must provide Warranty for two years from the date of installation and comprehensive Maintenance Contract (CMC) for three years after warranty, the response time to any fault should be not more than six hours after call is logged by E-mail/Fax/Phone call/SMS. Time for rectification should not be more than 48 hours. Maximum Downtime allowed without penalty is 72 years. Incase equipment is not useable beyond the stipulated maximum downtime the supplier will be required to install alternative equipment providing uninterrupted service.
