- 1) The bid documents will be received by **Speed Post only**, addressed to the Chief Medical Officer of Health, North 24 Parganas, Kolkata-700124.
- 3) The vehicle must be diesel operated and commercially registered.
- 4) No price preference should be given to any organization / Society
- 5) The bidder must have PAN, Service Tax Registration and Commercial Tax Registration of current validity
- 6) The vehicle for which the rate quoted, must not be more than five years old from the date of opening of the tender. Supporting document has to be submitted.
- 7) The vehicle will be hired on monthly basis, including driver and the proportionate daily rate should be quoted as per Annexure IV.
