“Expression of Interest” Notice

District Health & Family Welfare Samiti (RNTCP) North 24 Parganas is inviting EOI in a prescribed format from registered Non-Government Organisations (NGOs) for implementing different NGO schemes as mentioned in the “National guideline for partnership – 2014” under RNTCP. The details will be available in the notice board of the CMOH office and office of the DTO North 24 Parganas and also in web site www.north24parganas.gov.in & www.wbhealth.gov.in

The decision of the district level NGO selection committee is final and committee reserves the right to reject any application without assigning any reason thereof.

Eligibility criteria for the NGOs:

A. Registration:

1. NGO should be registered under the societies registration Act / Indian Trust Act / and charitable Act / Companies Act or the state counterparts of such acts for more than three years.
2. The NGO should preferably have office premises in the district of operation.
3. A NGO blacklisted or placed under funding restriction by any Ministry or department of the Government of India, State Government, or CAPART would not be eligible for applying under the scheme. NGO applying for projects under the NGO scheme should give an affidavit to this effect certifying that they have not been blacklisted by any Ministry or Department of the govt. of India or a State Government.

B. Experience:

1. At least three years of experience in district level project in health Sector Project or in the concerned Social Sector (e.g. community mobilization, health services, micro planning, IEC etc.)

C. Financial:

1. Annual turnover of at least Rs. 10Lakhs for district level project.
2. The NGO should be financially stable.
3. NGOs should have appropriate infrastructure, strong community outreach networks, stable governance structure, transparent financial system and flexible administrative norms.
4. Assets amounting to Rs. 2.5lakhs in the name of the organisation.
