- 5) The bidder must have PAN, Service Tax Registration and Commercial Tax
- 6) The vehicle for which the rate quoted, must not be more than five years old Registration of current validity from the date of opening of the tender. Supporting document has to be
- 7) The vehicle will be hired on monthly basis, including driver and the proportionate daily rate should be quoted as per Annexure IV.
