Price Basis: Price should be quoted all inclusive and includes delivery charges also. If there is a discrepancy between words and figures in the price quoted by the bidder, the amount shown in words will prevail.

Time of completion of delivery: Within 7 days from the date of issue of Purchase Order.

Earnest Money: Each tender must accompanied by Earnest Money deposit of Rs. 1000 /- (not bearing any interest) in the form of Pay Order / Demand Draft in favour of "District Health & Family Welfare Samiti, North 24 Parganas" from any Nationalized Bank / Schedule Bank. Earnest money of unsuccessful bidder will be refunded within one month from the date of opening of the bid or on finalization of tender process whichever is earlier.
