## **TERMS AND CONDITIONS**

- 1. That the Owner of the Launch shall have to submit a copy of the latest certificate of fitness of the Launch obtained from the Marcantile Marine Department alongwith the formal Tender.
- 2. That the intending tenderers must keep their Launch ready for inspection of trial before final acceptance.
- 3. The rent should be quoted monthly hire-basis. Necessary establishment charges and petty stores for running the Launch and necessary repairs should be borne by te owner himself, only fuel and lubricants will be supplied by this Department on free of cost according to requirement. If fuel and lubricants are required to be supplied by the owner of the Launch for some unavoidable circumstances the cost will be reimbursed on submission of bill in due courses.
- 4. Contract may be terminated at any time by a written notice of 15 days in case of any emergent necessity. No compensation of such termination will be in paid.
- 5. Contract may be terminated at any time by a written notice of 7 (seven) days if the launch does not give satisfactory service. No compensation on account of such termination will be paid
- 6. No compensation will also be paid by this Department for wear and tear and any damage. If any, of the launch during the hired period.
- 7. The launch will have to ply in Sundarban areas as per requirement.
- 8. If the launch is removed for survey or repair another almost similar to that hired launch should be placed in its place.
- 9. The launch will be hired ordinarily for period of three years i.e. 2013-2014, 2014-2015, 2015 2016. The period of hiring may be extended beyond the stipulated period as per necessity with the same terms and conditions.
- 10. The launch if accepted on hire by this Department should be placed at Hasnabad Ghat at their own cost. The launch will have to be taken back on termination of hired period also at their own cost.
- 11. Photo copies of the original survey certificate granted by the principal officer, Marcantile Marine, Kolkata will have to be submitted at the time of submission of tender.
