- Proper documents would be given in sealed envelope duly self attested by the applicant, original documents should be produced on demand.
- 3) The rate should be quoted both in figure and words on % basis clearly. The rate should be inclusive of all taxes and incidental charges.
- 4) They will have to deposit the Earnest Money @ 2% through a Demand draft as earnest money in favour of the District Magistrate, North 24 Pargagnas, MDM Scheme.
- 5) The Earnest money shall not attract any interest .The Earnest money of the unsuccessful Tenderer shall be returned within one month from date of finalization of tender.
