- Payment will be made, on satisfactory supply of all materials in good condition and as per quality prescribed, at the end of respective SDOs.
- Agency is also requested to submit credential certificate for similar type of work, if any.

3. Agency shall submit sample articles (15Pcs.) for each category.

4. ST/IT/VAT will be deducted as per existing Govt. norms.

- 5. If any item is found defective/damaged, that has to be replaced by the supplier immediately within a very short time and in that case extra cost (if any) will have to be borne by the supplier.
- 6. Materials, as required, will have to be supplied within 4(four)days from the date of issuance of supply
- 7. Suppliers will have to produce the sample of articles to the tender committee on demand on the same date of the finalization of the tender or on the next day without fail for consideration for acceptance.
