Tenders are hereby invited from the authorized agents for supplying of 125KVA Silent Generator. for North 24 Parganas District Hospital. Details will be available in the official website of North 24 Parganas – <u>www.north24parganas.@rg.in</u>. or from hospital store.

Tender papers along with terms and conditions and schedule to be handed over on cash payment of Rs.100.00 (Rupees one hundred) only from the Equipment Store Office of the undersigned which will be available on and from 13/10/11 to 20/10/11 up to 1.00 P.m. and the same will be received on 20.10.11 up to 1.00 P.m. and be opened on the same date at 2.00 P.m. with Sealed Cover addressing to the "Superintendent, North 24-Parganas District Hospital, Barasat.

The amount of earnest money is fixed for Rs.5,000.00 (Rupees Five thousand) only and the same is to be deposited either through Treasury Challan or Bank Draft in favour of the undersigned under the Head of Account 1443-00-101 which is refundable. Also contact the website – www.north24parganas.gov.in

The amount of Security money is amounted to Rs.10,000.00 (Rupees Ten Thousand) only for installation of the said Generator and will be kept in the office of the undersigned until finalization of the next Tender. The earnest money is to be refunded to the unsuccessful tenderness by the undersigned and the successful bidder will refund earnest money after depositing the Security Deposit.

The decision of the Tender Selection Committee is final for accept or rejection of any tender without assigning any reason.

#### **Terms and Conditions**

- One 125 KVA Silent Generator is to run 24 hours round the clock in North 24 Parganas. District Hospital, Barasat
- 2. Rate is to be quoted with fuel, mobil and distilled water etc. and without fuel, mobile and distilled water etc.
- 3. No Tender will be considered if the same is not submitted in the prescribed schedule as supplied from this office.
- 4. No extra charges for any kind of transportation will be borne by the undersigned.
- 5. Security money of the selected contractor will be forfeited in the event of failure to comply and violation of terms and conditions.
- 6. At least two year's experience certificate of any Government Institution in this respect is required.
  - 7. Xerox copy of PAN No., VAT No. if any, up to date P. Tax, Trade License of Municipality or Enlistment Certificate required.
- 8. Specification and other terms and conditions for the same will be supplied with the Tender Form.

### **Terms and Conditions**

- 1. The Agency must have S.C.C in part 1,2,3,4,6 (a), 6 (b), 7(a), 7(b) and 11 only and they should have at least 2 (Two) years past experience in similar type of works in state P.W.D or other Govt. or Semi Govt. department.
- 2. The 125KVA silent Generator to be supplied by he Agency must not be more than 3(Three) year old.
- 3. Fuel and lubricant will be supplied by Agency as and when required.

- 4. Standby generator of the same capacity must be provided by the Agency as soon as the fault occurred in the existing silent Generator and no additional charge will be paid.
- 5. The Agency will depute responsible and experienced generator operator with valid license and the salary of he operator must be included in the hiring charge of the Generator.
- 6. The Agency is to operate the Generator as and when required in case of any sort of power failure.
- 7. The Agency should have Telephone/Mobile for quick communication
- 8. The contract may be terminated with at least two months notice from either side.
- 9. The agency will be responsible for making good damages basis. The payment will be made on available of fund.
- 10. The bill for the work should be submitted on quarterly basis. The payment will be made on available of fund.
- 11. The authority will not be responsible for safety and security of the Generator and no additional payment will be made for any type of damages.
- 12. The Agency should maintain a separate log book serially numbered and to be certified by the Superintendent, District Hospital or any other person authorized by him.
- 13. The decision of the selection committee is final for acceptance or rejection of the tender without assigning any reason.
- 14. Generator is to run 24 hours round the clock if required if the contractor fails to provide generator service during power cut no payment will be made for the period. Moreover if this happens the 5 times of the cost for the period will be deducted from the monthly bill.
- 15. If the Agency fails to provide alternative generator then 50% of the payment will be deducted from the monthly bill.
- 16. Any failure in abducing there terms and condition may lead to termination of the contract without any prior intimation.
- 17. The period of contract is for three consecutive years.
- 18. In case of rise in the price of the fuel a maximum amount of 5% enhancement in the bill is permitted every year. Depending on decision of authority
- 19. One SLA will be signed between both the parties.
- 20. The tender bid should be submitted in two parts i) Technical bid, ii) Commercial bid.
