1. General Instructions:-

In the event of E-filing, intending Bidder may download the Tender Documents free of Cost from the website: <https://wbtdenders.gov.in> and www.north24pgs.gov.in with the help of Digital Signature Certificate or from the Health & Family Welfare Department's Website www.Wbhealth.gov.in & necessary Earnest Money to be submitted for participation in the tender through online mode as per guideline laid down in the Finance Department, Govt. of West Bengal memorandum no. 1973-PYI, Date: 28.07.2017 issued from any nationalized bank in the form of **ONLINE PAYMENT/NEFT** and also to be documented through e-filing.

2. Submission of Bids:-

Both Technical Bid & Financial Bid are to be submitted concurrently duly digitally signed by the company personnel only **(having Authorization from the company movement) in the website** <https://wbtdenders.gov.in>. All papers must be submitted in English Language with Page Marking.

3. Time & Schedule for the E-Tender: The time and date for obtaining the Bid Documents, Pre Bid Meeting and Registration with the tendering Authorities, The Submission of bids and other Documents etc. will be as per the list provided in clause, as given below.

4. **Eligibility for Quoting:** The invitation for bid is open to all for providing the above services having the requisite certificates and credentials as enlisted below.

The folder as "Financial Bid" shall contain Base rate per Accounting Unit exclusive/GST tax to be quoted.

TERMS AND CONDITIONS OF THE TENDER

1) Minimum Eligibility Criteria:

- a. Only those firms/agencies (having Trade license such type of Business) & who have experience in such type of job of at least (1)one year and have satisfactory supply of order in Govt. Institute. (Marginally will be preference) Agencies/Supplier must have Food Safety License from Department of Health.

2) Bidder will be required to deposit Rs. 10,000/- (Rupees Ten Thousand) only as EMD (Earnest Money Deposit)

- a. The successful tenderer (s) will have to deposit security Money Rs.30000/-in the form of Pay Order/Bank Draft in favour of 'Habra S.G. Hospital, RKS'. The earnest money will be forfeited if the tenderer(s) fail to deposit the security Money Deposit within 7 (Seven) days of acceptance of the Offer Letter.

- b. The unsuccessful Tenderer(s) will receive their earnest money back in time. The earnest money will be refunded after the deposit of full amount of security Money of successful tenderer(s).

Tenderer(s).

- 1) The earnest money will be forfeited if the tenderer (s) withdraws the tender after opening of bids.
- 2) EMD exemption is allowed for those having SS. (MEME) Part II or NSIC certificate.
- 3) Documents required for Technical Bids are contained in specimen Form of Technical Bid.
- 4) Above rate can't be accepted.
- 5) The selected bidder will also have to pay the rent of the canteen on monthly basis and after providing continuous six months satisfactory performance by the selected bidder such rent will increase by ten percentages (10%) every year. If continuous six months satisfactory performance is not obtained from the selected bidder, the Superintendent shall have the power to terminate such bidder without assigning the reason.
- 6) Bidders will have to present original requisite documents in support of uploaded documents for verification, if asked for.
- 7) The Tender is valid only for the mention canteen only under the control of Superintendent, Habra SG Hospital.
- 8) The Earnest Money may be kept in custody of the authority as a part of Security Deposit of the successful bidder(s) and will be released after expiry of the tender period if bidder expresses in written.
- 9) Earnest Money will be returned to the unsuccessful bidder through online mode or in written request on production photocopy of demand draft. No interest will be payable on the EMD.
- 10) In case it is found that two or more bidders have quoted same price, the lowest bidder will be decided by draw of lots.
- 11) Any co-operative without having proper permission (from Competent Authority for such job) of concerned business will not be entitled to get exemption of EMD security deposit and/or any rate preference.
- 12) All terms and conditions as mentioned above will have to be accepted by the Tenderer (s).
- 13) Timelines for downloading and submission of E-Tender along with other datelines has been noted below.
- 14) E-Tender should be addressed to the Superintendent of Habra SG Hospital, Bidders may download tender enquiry documents from the website www.north24pgs.gov.in and www.wbhealth.gov.in.
- 15) Any subsequent notice regarding this tender shall be uploaded in above website only or the interested parties may contact to the office of the auth. signed for more details.
- 16) Financial Bids are attached herewith (DOQ).
- 17) The authority reserves the right to accept or reject any tender in part or in full even in the entire tender process at any time prior to the award of contract without assigning any reasons there for.
- 18) If rate of any item attraction then it will be nearest rounded figure, that is, 5 or above calculated to next rupee and below will be ignored.
- 19) Self help group registered before 31/03/2022 is preferable.

Other Terms & Condition for FOOD & Hygiene as per FSSAI & sch-IV

- 1) The utensils & other furniture should be good condition.
- 2) The food should be hygienic & fresh as per specification and socially acceptable.
- 3) Timely supply of cooked food.
- 4) Quality should be maintained otherwise supplier will be rejected as per the standards.
- 5) Rate including all charges including servicing or packaging charges.
- 6) Refusal of supply and poor quality of food, mis behavior of supplier, etc happens then the contract will be cancelled for further supply.
- 7) Mineral water, ice cream, cold drinks or any other items which are not included in the DOQ may be prepared by per market rate.
- 8) Only cooked only (veg, non-veg) items should be used as per FSSAI Rule & Regulation, 2011.
- 9) Fruits, vegetables & others food item washed before cooked with potable water.
- 10) No adulterant to be used.
- 11) Fly catcher to be installed with well exhaust system.

SPECIAL TERMS AND CONDITIONS FOR CANTEEN SERVICE ON CONTRACT

1. Canteens of this Habra SGH:
 - A. Hospital premises Canteen - Supply cooked food with cooking service facility.
The tender should have at least 10 (ten) years of catering experience of serving at least 200 persons in a organization. Suitable documentary evidence to be supported along with the expression of interest application.
2. Canteen shall be meant for serving refreshments, snacks, tea, meals, etc. and such other items and at such prices, as may be settled between the contractor and the hospital authority.
3. The services of the canteen will be at the disposal of the staff of this hospital including doctors, other officers, nurses, etc., and bonafide visitors. The users of the canteen shall be paying for the services directly to the Interest Parties.
4. The canteen will run on all days including Sundays & holidays and shall remain open (24*7) during such hours as may be decided by the authority.
5. **The selling price of all the food items to be sold at the subsidised rate (20% to 30% less than the local market price) which may be varied item wise and it should be under the discretion of hospital authority.**
6. Only mustard oil/vegetable oil/groundnut sunflower oil is permitted for cooking and oil cooked only 2 times & then discarded the next day.
7. The ESC will pay regular visit to the canteen to supervise and check the quality & quantity of the food items served in the canteen.
8. The personnel appointed by the Interest Parties must have proper and clean uniform for the identification. The personnel so appointed should have the basic knowledge of personal hygiene and safe & clean method so food handling. Health checks up of canteen staffs & vaccination is mandatory.
9. The quality of the raw materials to be used for preparation of food in the staff canteen should be at highest standard and fresh. Fridge/Refrigerator facility will be available. Quality of all kind of food & service will be reviewed regularly.
10. The Fuel to be used for cooking will only be LPG and shall be arranged by the contractor. The contractor should have valid commercial connection in its name.
11. Fire safety provisions to be installed at canteen.
12. The contractor will be responsible for maintaining adequate number of persons engaged in: Cooking, distribution of food and disposal of garbage and left over food.
13. The contractor should keep the canteen complex clean. If, at any point the Canteen & its premises are found to be unclean, the contractor shall be held responsible and action deemed fit shall be taken by the competent authority.
14. The contractor shall bear all the expenses for running the canteen and the authority shall not in any manner be liable for any damage caused on incidents like theft, burn, fire, electric shock or bear any compensation for damage or injury or injury caused to its workmen during discharging their duty.
15. The contractor shall not be entitled to use the accommodation allotted by the authority for any other purpose or business so the management.
16. The persons associated with preparation and distribution of food will be required to undergo periodical medical checkups to rule out the possibilities of communicable disease / infection diseases and any body found suffering from such has to be kept out of engagement till he / she is fully recovered.

17. The list of personnel deployed for food preparation, handling and serving have to be intimated to the authority from time to time.
18. There shall be no compromise on the quality of food supplied by the Interest Parties and if any such incidence or food adulteration is found, action deemed fit, including black listing the firm, shall be taken by the Competent Authority and all the FSSAI act 2006 & FSSAI rule & regulation, 2011 will apply.
19. The contractor will be responsible for strict conduct of the persons engaged by him in the canteen, which will be conducive for maintaining the harmonious atmosphere in the hospital and will be responsible for any act commission & omission of such persons.
20. Use of plastic cup & carry bag will be strictly prohibited at the Hospital campus.
21. The contract, if awarded, will be initially for one year from the date of award of Contract subject to continuous satisfactory performance and on failure on this aspect, the authority reserve the right to terminate the contract. The period of one year can be extended for a further period at the discretion of the hospital authority, but not more than one year with the existing terms and conditions.
22. This Institution Campus is a "NO SMOKING and NO ALCOHOL BEVERAGE ZONE" hence sale and use of tobacco is prohibited.
23. Free of cost food to be provided to all the staff of the institution.
24. Packaging of various food items should adhere to the norms of food habit.
25. The selection of vendor will be taken upon as per E-Tender specification and additional revenue promised for payment to Government as well as authority (not applicable for Government agency).
26. Proper display of rate chart (food) in should mandatory at reception or cash counter and outside the canteen area in the local language.
27. All food samples tested periodically.
