A public auction of the large quantity of following condemned/unserviceable stores will be conducted on 21<sup>st</sup> May 2019 at 1100 hrs at BN HQ , 85 Bn BSF, Digberia, Badu Road, 24 PGN (N), Kolkata :-

- (i) Utensils (Metal)
- (ii) Tentage/Fire Fighting/iron pickets/GI Pipes etc (Metal)
- (iii) News Paper & Magazines
- (iv) Ammunition boxes (Metal)
- (v) Electrical/plumbing stores (Metal/Plastic)
- (vi) Old Tyres & Tubes
- (vii) Batteries
- (viii) Spare Parts of vehicles (Metal)
- (ix) Other Misc scraps

**2. Terms and Conditions**

- a. All interested bidders are requested to attend the auction on scheduled date and time.
- b. Every intending bidder will have to deposit Rs. 10,000/- (Rupees Ten thousand) only in advance as Banker Cheque/Bank Draft in favour of Commandant, 85 Bn BSF payable at SBI Digberia as earnest money at least one hour before the scheduled time of auction, which will be adjusted/refunded after finalization of auction on the same day.
- c. All bidders must be in possession of their PAN Cards and Income Tax clearance certificate in original and copy of GST registration certificate which will be scrutinized by the auction board, failing which they will not be allowed to participate in the auction.
- d. The stores will be sold on "as is where is basis". The auction process will be conducted by auction committee of this office. Taxes and duties (GST) that may be levied by Govt of India will be extra as applicable.
- e. The bidders will be allowed to inspect the said stores.
- f. Other terms and conditions will be announced by the board of officers appointed for the purpose before commencement of the auction.
- g. The successful bidders shall have to deposit 25% value of the auctioned store plus admissible taxes/surcharge immediately in the shape of Cash/Bank draft as earnest money after the auction is over.
- h. The successful bidder will be permitted to lift the stores only after receipt of full payment and has to be lifted within 05 (five) days of completion of deal failing which ground rent at the rate of Rs. 200/- per day will be charged for further 05 days. There after his earnest money will be liable to be forfeited and shall be deposited into Govt treasury and the stores will again put up for action. Transportation at their own arrangements and labour will not be provided by this Battalion for carrying/shifting of auctioned stores.
- i. Once the release order issued, this office will not be responsible either for safe custody or for any loss or damage to the above stores.
- j. The decision of the auction committee for all the purpose shall be final and binding.
- k. The Commandant, 85 Bn BSF reserved the right to reject any or all the bidders without assigning any reasons. The decision of the Commandant, 85 Bn BSF will be final in this regard during the process of this auction at any stage.
