WHEREAS, the Election Commission vide Press release Note No. ECI/PN/23/2024 Dated 16th March, 2024 declared the schedule for General Election to the Lok Sabha, 2024 and the said Election will be held on 01/06/2024 in 18-Basirhat Parliamentary Constituency.

AND

WHEREAS, the Election Commission vide Notification No. 464/EPS/2024(7) Dated the 07th May, 2024 has decided the time of Poll for 18-Basirhat Parliamentary Constituency on 01/06/2024 from 07.00 AM to 6.00 PM.

AND

WHEREAS, for smooth conduct of Elections, all the international Borders (Land) routes (entry and exit) need to be sealed and movement of both people and vehicles be restricted from 06.00 pm on P-3 day i.e. 29/05/2024 till completion of the polling process.

Therefore, I, Sri Sharad Kumar Dwivedi, I.A.S. District Magistrate, North 24 Parganas in exercise of the power conferred upon me u/s 144(2) of the Criminal Procedure Code, 1973, do hereby promulgate this order restraining the movement of both people and vehicle for exit to Bangladesh and entry to Indian territory from Bangladesh under Basirhat P.C of North 24 Parganas District with effect from 06.00 pm on 29/05/2024 till completion of the polling process.

Exemptions of this order shall be allowed in case of :

- 1) Medical emergency cases to travel from Bangladesh to India,
- 2) Voters of 18-Basirhat Parliamentary Constituency,
- 3) Vehicles containing perishable goods.

Subject to satisfaction of Border-in charge regarding nature of emergency supported by valid documents.

The Superintendent of Police, Basirhat Police District, North 24 Parganas district is requested to serve the order to all concerned.


