- Applications open from: 01.01.2022 to 11.09.2022

- Date of the exam: 25.09.2022 (Sunday)
- Documents for application: Student should have a valid functional Mobile Number, Aadhar Number (UID), Aadhar linked Bank Account, Income Certificate and Caste Certificate.
