

ORDER

Whereas Authorized Officer, UCO Bank, Chakbarbaria Branch, Masjidbari Road, Chakbarbaria, PO – Noapara, PS – Duttapukur, North 24 Parganas, PIN – 700 125, has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Co-Borrower namely Sri Krishnakanta Roy S/o. Sri Jogesh Chandra Roy & a Guarantor namely Smt. Rina Roy W/o. Sri Krishnakanta Roy, of the Borrower namely Sri Ujjal Roy S/o. Sri Krishnakanta Roy, all are residing at, Netajipally, PO – Noapara, PS – Duttapukur, North 24 Parganas, PIN – 700 125. (Case No – 166/23/MN)

whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, UCO Bank, Chakbarbaria Branch, Masjidbari Road, Chakbarbaria, PO – Noapara, PS – Duttapukur, North 24 Parganas, PIN – 700 125 seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor granted a loan Rs. 17,00,000.00 (Term Loan) (HBL) (Rupees Seventeen Lac Only) on 28.02.2019 to Borrower namely Sri Ujjal Roy S/o. Sri Krishnakanta Roy, having a Co-Borrower namely Sri Krishnakanta Roy S/o. Sri Jogesh Chandra Roy & a Guarantor namely Smt. Rina Roy W/o. Sri Krishnakanta Roy, all are residing at, Netajipally, PO – Noapara, PS – Duttapukur, North 24 Parganas, PIN – 700 125, against the all the mortgaged piece and parcel of landed property as follows:

3) Notice dated 21.09.2021 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs. 16,01,532.00 (Rupees Sixteen Lac One Thousand Five Hundred and Thirty Two) Only. The Demand notice was published in two daily news papers on 24.09.2021

The Authorised Officer of the secured creditor received no representation from the borrower in reply to demand notice u/s 13(2)

5) The Secured creditor issued possession notice dated 19.01.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 20.01.2022

6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor

- whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land And

The property is not under leesee/tenancy as per affidavit, deed(s), records or all other relevant documents

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of UCO Bank, Chakbarbaria Branch, Masjidbari Road, Chakbarbaria, PO – Noapara, PS – Duttapukur, North 24 Parganas, PIN – 700 125, the secured creditor and being satisfied, it is hereby ordered that Sri Lakshmi Kanta Roy, Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the District Magistrate, North 24- Parganas, under the District Magistrate North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditors u/s 14 (1A) of SARFAESI act. 2002
