ORDER

Whereas Authorized Officer, Punjab National Bank, Circle Sastra, 24 Parganas (North) Circle, Barasat, 48-A, Jessore Road, Barasat, (Near Seth Pukur), Kolkata – 700 124 has filed a petition u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Proprietor, Guarantor & Co-Borrower Sri Abdul Ohab S/o. Sri Abdul Sattar, residing at, Vill – Aminpur, PO + PS – Deganga, North 24 Parganas, PIN – 744 423, of the Borrower namely M/s. Janaseba Medical Stores, situated at, Vill & PO – Debalaya, PS – Kharda, North 24 Parganas, PIN – 743 424. (Case No – 138/23/MN)

and

Whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Punjab National Bank, Circle Sastra, 24 Parganas (North) Circle, Barasat, 48-A, Jessore Road, Barasat, (Near Seth Pukur), Kolkata – 700 124, seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

and

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor Granted a loan Rs. 18,00,000.00 (Overdraft) (Rupees Eighteen Lac Only) on 30.05.2017 + Rs. 1,80,000.00 (GECL) (Rupees One Lac Eighty Thousand Only) on 19.03.2020 + Rs. 3,50,000.00 (WCTL) (Rupees Three Lac Fifty Thousand Only) on 20.06.2020 to Borrower namely M/s. Janaseba Medical Stores, situated at, Vill & PO – Debalaya, PS – Kharda, North 24 Parganas, PIN – 743 424, having a Proprietor, Guarantor & Co-Borrower Sri Abdul Ohab S/o. Sri Abdul Sattar, residing at, Vill – Aminpur, PO + PS – Deganga, North 24 Parganas, PIN – 744 423, against the all the mortgaged piece and parcel of landed property as follows:

SCHEDULE OF PROPERTY

- 1) All that piece and parcel of Landed property measuring an area more or less 16 Satak with a building lying and situated at Mouza Aminpur, JL No. 74, Re Sa No. 141, Touzi No 683, Sabek Khatian No. 114, Hal Krishi Khatian No. 219, RS & LR Dag No. 554, Own New Khatian No. 1074 & 1075 (as Mutation certificate no. 1504074 dated 06/03/2017, area of land 08 Satak each khatian comprising of two Dag i.e. 16 Satak). The Mortgaged Property stands in the name of Sri Abdul Ohab S/o. Sri Abdul Sattar and being the registered Deed No. I 70 for the year 2002 and the deed is registered at the office of A.D.Ś.R- Deganga, North 24 Parganas, West Bengal.
- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specifiedamount and consequent to such default in repayment, the account of borrower was classified as NPA on 01.07.2021 due to non servicing of interest/installment
- 3) Notice dated 13.09,2021 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The total outstanding amount as mentioned in notice is Rs 23,42,224.25 (Rupees Twenty Three Lac Forty Two Thousand Two Hundred Twenty Four and Twenty Five Paise) only and the demand notice was received by the borrower on 28.09.2020.
- 4) The Authorised Officer of the secured creditor received no representation from the borrower in reply to demand notice u/s 13(2) dated 13.09.2021
- 5) The Secured creditor issued possession notice dated 28.01.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 01.02.2022
- 6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor

and

7) whereas, the Secured Asset in within the jurisdiction of the District Magistrate, North 24- Parganas

and

- 8) whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land and
- 9) whereas, the secured creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the secured asset / property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(ies) as per law in force

and

whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

and

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the secured creditor and as per affidavit dated 09.08.2023 submitted by the secured creditor there is no stay declared by any court of law.

and

12) The property is not under leesee/tenancy as per affidavit, deed(s), records or all other relevant documents

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of Punjab National Bank, Circle Sastra, 24 Parganas (North) Circle, Barasat, 48-A, Jessore Road, Barasat, (Near Seth Pukur), Kolkata - 700 124, the secured creditor and being satisfied, it is hereby ordered that Sri Rajib Sardar, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the Sub Divisional Officer, Barasat, North 24- Parganas, under the District Magistrate North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditors u/s 14 (1A) of SARFAESI act. 2002

Whereas Authorized Officer, Punjab National Bank, Circle Sastra, 24 Parganas (North) Circle, Barasat, 48-A, Jessore Road, Barasat, (Near Seth Pukur), Kolkata - 700 124, will intimate the date of possession of the secured asset to the The Superintendent of Police, Barasat Police District, as well as to, Sri Rajib Sardar, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the Sub Divisional Officer, Barasat, North 24- Parganas, well in advance to take physical possession of the secured assets/Property of the secured creditor on behalf of District Magistrate, North 24- Parganas, the The Superintendent of Police, Barasat Police District, will provide police force for maintenance of law & order. The secured creditor will remain present at the time of taking over physical possession

A spot videography should be made in Connection with taking over physical possession of secured assets, on the date of taking over possession and soft copy of the videography should be kept under custody

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
