Whereas Authorized Officer, Cholamandalam Investment and Finance Company Ltd, 55 & 55/1, Chowringhee Road. 5th Floor, Chowringhee Road, 5th Floor, Chowringhee Road, 5th Floor, Chowringhee Court, Opp. Nehru Childrens' Museum in Rabindra Sadan, Kolkata – 700 071 has filed a petition u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured assets/Property of the Coborrower namely Sri Prince Biswas S/o. Gurupada Biswas of the Borrower namely Smt. Juthika Biswas, both are residing at, Nandan Kanan, Maniktala Anowarberia, Habra I, North 24 Parganas, PIN – 743 263, having other Co-Borrowers namely Biswas Wood Suppliers & M/s. Biswas Traders, both are situated at, Anowerberia, Nandan Kanan, PS – Habra, PO – Maniktala, Akrampur, PIN – 743 263, (Case No – 81/24/MN)

Whereas in the light of above order the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Cholamandalam Investment and Finance Company Ltd, 55 & 55/1, Chowringhee Road. 5th Floor, Chowringhee Road, 5th Floor, Chowringhee Court, Opp. Nehru Childrens' Museum in Rabindra Sadan, Kolkata – 700 071, seeking administrative assistance in terms of sec 14(1) of the SARFAESI Act of 2002 for taking over physical possession of the secured asset is/are seen and taken up for consideration

and

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that the secured creditor Granted a loan Rs. 26,19,000.00 (Rupees Twenty Six Lac Nineteen Thousand Only) on 28.03.2019 & 10.10.2020 to Borrower namely Smt. Juthika Biswas, having the Co-borrowers namely Sri Prince Biswas S/o. Gurupada Biswas, Biswas Wood Suppliers & M/s. Biswas Traders, both are situated at, Anowerberia, Nandan Kanan, PS – Habra, PO – Maniktala, Akrampur, PIN – 743 263 against the all the mortgaged piece and parcel of landed property as follows:

SCHEDULE OF PROPERTY

- 1) All that piece and parcel of Landed property measuring an area more or less 2 Cottah together with structure standing thereon lying and situated at Mouza Kutulsahi Comprised in J.L.No 42, R.S>No 10, Touzi No 10, Khatian No 113, Hal Khatian No- 115, L.R. Kri Khatian No 22, L.R.Khatian No 562 and 563, R.S. & L.R.Dag No 561, Holding No 315, Kutul Sahi Road, PS Barasat, North 24 Parganas, within the ambit of Barast Municipality, North 24 Parganas. The Mortgaged Property stands in the name of Sri Prince Biswas S/o. Gurupada Biswas and being the registered Deed No. I 150300066 for the year 2019 and the deed is registered at the office of ADSR-barasat, North 24 Parganas, West Bengal.
- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specifiedamount and consequent to such default in repayment, the account of borrower was classified as NPA on 30.04.2021 due to non servicing of interest/installment
- 3) Notice dated 24.09.2021 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The total outstanding amount as mentioned in notice is Rs 29,09,087.80 (Rupees Twenty Nine Lac Nine Thousand Eighty Seven and Eighty Paise) only and the demand notice was published in two daily news papers on 23.10.2021.
- 4) The Authorised Officer of the secured creditor received no representation from the borrower in reply to demand notice u/s 13(2) dated 24.09.2021.
- 5) The Secured creditor issued possession notice dated 25.02.2022 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 28.02.2022
- 6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor

7) whereas, the Secured Asset in within the jurisdiction of the District Magistrate, North 24- Parganas

and

- 8) whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land and
- 9) whereas, the secured creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the secured asset / property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(ies) as per law in force

and

whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

and

There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the secured creditor and as per affidavits submitted by the secured creditor there is no stay declared by any court of law

and

The area dutie not under lesses tenency as nor officiality

The property is not under leesee/tenancy as per affidavit, deed(s), records or all other relevant documents

and

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1)B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of Cholamandalam Investment and Finance Company Ltd, 55 & 55/1, Chowringhee Road. 5th Floor, Chowringhee Road, 5th Floor, Chowringhee Court, Opp. Nehru Childrens' Museum in Rabindra Sadan, Kolkata – 700 071, the secured creditor and being satisfied, it is hereby ordered that Sri Lakshmi Kanta Roy, Executive Magistrate by Sub Section (1) of Section 20 of the Criminial Procedure, 1973 (Act 2 of 1974), in the Office of the District Magistrate, North 24- Parganas, under the District Magistrate North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditors u/s 14 (1A) of SARFAESI act. 2002

The secured creditor will remain present at the time of taking over physical possession

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
