Order

Whereas Authorized Officer, Punjab National Bank ,North 24 Parganas Circle Sastra, 48, Jessore Road, Barasat (Near Seth Pukur) Barasat, Kolkata-700124 has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured Asset / Property of the Borrower namely Ideal Agro Food Products , Prop. Tilack Roy Chowdhury, Busi. Add.-Jugberia, Talbanda, Bilkanda , P.O.- Jugberia, P.S.- New Barrackpore, Dist.- North 24 Parganas. Pin.- 700110, Residential Add.-(77)53/C/1, Karunamoyee Road, P.O- Talpukur, P.S-Titagarh, Dist.- North 24 Parganas. Pin.-700110 & Keya Roy Chowdhury, IIa Roy Chowdhury (Gurantor), in the Case No.: 566 / 23 dated 30/06/2023 .

Whereas in the light of above matter the petition along with affidavits and other relevant documents submitted by the Authorised Officer, Punjab National Bank ,North 24 Parganas Circle Sastra, 48, Jessore Road, Barasat (Near Seth Pukur) Barasat, Kolkata-700124 has filed a petition to the District Magistrate, North 24-Parganas seeking administrative assistance in terms of Section 14 (1) of the SARFAESI Act of 2002 for taking over physical possession of the Secured Asset is seen and taken up for consideration.

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that secured creditor granted loan of Rs. 23,00,000.00 (TwentyThree Lakhs) only on 21.10.2020 and Rs.1,90,000.00 (One Lakhs Ninety Thousand) only on 30.06.2020 to the Borrower viz. Ideal Agro Food Products , Prop. Tilack Roy Chowdhury, Busi. Add.- Jugberia, Talbanda, Bilkanda , P.O.- Jugberia, P.S.- New Barrackpore, Dist.- North 24 Parganas. Pin.- 700110, Residential Add.-(77)53/C/1, Karunamoyee Road, P.O- Talpukur, P.S-Titagarh, Dist.-North 24 Parganas. Pin.-700110 & Keya Roy Chowdhury, IIa Roy Chowdhury (Gurantor), against the mortgaged piece and parcel of landed property as follows:

Schedule of Property

1) All that piece and parcel of BASTU land with building thereon measuring 3 katha 6 Chiitak 03 sq ft lying and situated at Mouza- Chanak, JL No-4, Touzi No- 2998, Re Sa No-39, CS & RS Khatian No-589, CS Dag No-720, RS Dag No-6721, under ward no-12, of Barrackpore Municipality, holding No-77(53/C/1), karunamoyee road, P.O-Talpukur, P.S- Titagarh, Kolkata-700123, Dist- North 24 Parganas, by Virtue of a registered sale deed recorded in Book No-1, Vol No- 83, Page 51 to 54, being no-5080 for the year 1974 at SR Barrackpore.

- 2) The borrower has committed default in repayment of the financial assistance granted aggregating the specified amount and consequent to such default in repayment, the account of borrower was classified as NPA on 01.12.2022 due to non servicing of interest/ installment
- 3) Notice dated 17.12.2022 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs. 24,62,235.79 (Twenty Four Lakhs SixtyTwo Thousand Two Hundred ThirtyFive and SeventyNine paisa) only and delivered on 20.01.2023.
- 4) The Authorised Officer of the secured creditor received no representation from the borrower in reply to demand notice u/s 13(2) dated 17.12.2022.
- 5) The Secured creditor issued possession notice dated 10.03.2023 u/s 13(4) of SARFAESI Act of 2002 for taking Possession on the secured assets of the borrower and also published the same in the daily news papers on 11.03.2023.
- 6) Thus the Authorised Officer of the secured creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the secured debtor
- 7) Whereas, the Secured Asset in within the jurisdiction of the District Magistrate, North 24- Parganas
- And 8) Whereas, the amount dues more than 20% of the Principal Advance and Security interest is not created in any agricultural land
- 9) Whereas, the secured creditor wants to reconstruct their financial asset(s) after handing over and taking over physical possession of the secured asset / property as scheduled above, belonging to the Borrower(s) / Coborrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(ies) as per law in force

10) Whereas, for the purpose of taking possession of the secured asset(s) and documents, the secured creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act of 2002.

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the secured creditor and as per affidavit dated 26. 06.2023 submitted by the secured creditor there is no stay declared by any court of law.

12) The property is not under leesee/tenancy as per affidavit, deed(s), records or all other relevant documents

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1) B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the secured creditor filed duly affirmed by the authorized officer of Punjab National Bank ,North 24 Parganas Circle Sastra, 48, Jessore Road, Barasat (Near Seth Pukur) Barasat, Kolkata-700124 has filed a petition to the District Magistrate, North 24-Parganas, the secured creditor and being satisfied, it is hereby ordered that Sri Pinaki Sankar Biswas Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub Divisional Officer, Barrackpore, North 24- Parganas, under the District Magistrate North 24 Parganas will take physical possession of the secured assets/property and forward the same to the secured creditor u/s 14 (1A) of SARFAESI act. 2002.

Whereas Authorized Officer, Punjab National Bank ,North 24 Parganas Circle Sastra, 48, Jessore Road, Barasat (Near Seth Pukur) Barasat, Kolkata-700124 has filed a petition to the District Magistrate, North 24-Parganas shall intimate the date of possession of the secured asset to the Commissioner of Police, Barrackpore Commissionerate , North 24 - Parganas, as well as to, Sri Pinaki Sankar Biswas , Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub Divisional Officer, Barrackpore , North 24- Parganas under The District Magistrate, North 24 Parganas, well in advance to take physical possession of the secured assets/Property of the secured creditor on behalf of District Magistrate, North 24- Parganas, The Commisioner of Police, Barrackpore Commissionerate , North 24 - Parganas, will provide police force for maintenance of law & order. The secured creditor will remain present at the time of taking over physical possession.

A spot videography should be made in connection with taking over physical possession of secured assets, on the date of taking over possession and soft copy of the videography should be kept under custody.

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
