Order

Whereas Authorized Officer, Indian Bank (E-Allahabad Bank), Paikpara Branch, 54 Talapark Avenue, Paikpara, Kolkata - 700037 has filed a petition to the District Magistrate, North 24-Parganas, u/s 14 of SARFAESI Act of 2002 seeking administrative assistance for taking physical possession on the secured Asset / Property of the Borrower namely Smt. Rinku Das, W/o Sri Partha Das, Residing At: Flat No. - 3B, 3rd Floor, Purnashree Apartment, 109 Pirtala Road, Pallishree, Shyamnagar, Jagaddal, North 24 Parganas, West Bengal, Pin-743127, Also At - 54 Surpara Road, Bhatpara, Noapara, Dist. - North 24 Parganas, West Bengal, Pin-743128 having no Co - Borrower / Guarantor in the Case No.: 484/23 dated 06.06.2023.

Whereas in the light of above matter the petition along with affidavits and other relevant documents submitted by the Authorised officer, Indian Bank (E-Allahabad Bank), Paikpara Branch, 54 Talapark Avenue, Paikpara, Kolkata - 700037 seeking administrative assistance in terms of Section 14 (1) of the SARFAESI Act of 2002 for taking over physical possession of the Secured Asset is seen and taken up for consideration.

Whereas from the documents and status report submitted by the Authorised Officer, it transpires that secured creditor granted Ioan of Rs. 18,00,000.00 (Rupees Eighteen Lakhs) only on 26.03.2018 to the Borrower viz. Smt. Rinku Das, W/o Sri Partha Das, having no Co - Borrower / Guarantor against the mortgaged piece and parcel of landed property as follows:

Schedule of Property

All that a self contained residential Flat No. 3 B on the 3rd Floor in G+3 storied building named 1) Purnasree Apartment at 109 Pirtala Road (Pallisree) Ward No. 23, P.O. Shyamnagar , P.S. Jagaddal ,District North 24 Parganas, Pin Code 743127, Flat is measuring 855 sq. ft. more or less with undivided proportionate share in land area 06 cottahs 02 chittacks 38 sq.ft. be the same a little more or less with right to use common areas, common passages etc alienated with the said building comprised in the R.S. Dag No. 1305 corresponding to the L.R.Dag No. 2787 in the R.S. Khatian No. 731 at Mouza Mulajore, J.L. No. 18, P.S. Jagaddal under Bhatpara Municipality, North 24 Parganas. The Mortgaged Property stands in the name of Smt. Rinku Das, W/o Sri Partha Das. The property is butted & bounded by: North - Property of Dulu Rani Dey & Others, South - Property of Rubi Chakraborty, East - 20'wide Peertala Road & West - Property of Others.

The borrower has committed default in repayment of the financial assistance granted aggregating the 2) specified amount and consequent to such default in repayment, the account of borrower was classified as NPA on 29.10.2022 due to non-servicing of interest/ installment.

- Notice dated 19.11.2022 u/s 13(2) of SARFAESI Act. 2002 demanding payment of default amount was 3) served to the defaulting borrower. The outstanding amount as mentioned in notice is Rs. 21,50,773.00 (Rupees Twenty One Lakhs Fifty Thousand Seven Hundred & Seventy Three) only and the demand notice was served on 19.11.2022.
- The Authorised Officer of the Secured Creditor received no representation from the borrower in reply 4) to demand notice u/s 13(2) dated 19.11.2022.
- The Secured Creditor issued possession notice dated 03.02.2023 u/s 13(4) of SARFAESI Act of 2002 for 5) taking Possession on the secured assets of the borrower and also published the same in the daily newspapers on 05.02.2023. 6)
- Thus the Authorised Officer of the Secured Creditor observed all the formalities as laid down in the SARFAESI Act 2002 for realization of the said outstanding amount from the Secured Debtor And
- Whereas, the Secured Asset is within the jurisdiction of the District Magistrate, North 24 Parganas. 7) And
- Whereas, the amount dues is more than 20% of the Principal Advance and Security Interest is not 8) created in any agricultural land.
- And Whereas, the Secured Creditor wants to reconstruct their financial asset(s) after handing over and 9) taking over physical possession of the Secured Asset / Property as scheduled above, belonging to the Borrower(s) / Co-borrower(s) / Director(s) / Guarantor(s) / Partner(s) / Proprietor(s) / Corporate Guarantor(s) / Surety(s) as per law in force.

And

Whereas, for the purpose of taking possession of the Secured Asset(s) and documents, the Secured Creditor requested the District Magistrate, North 24 Parganas u/s 14 of SARFAESI Act, 2002.

And

11) There is no case pending before any court of law under Section 34 of SARFAESI Act, 2002 in this regard filed by the borrower as per '30 Clauses' declaration submitted by the Secured Creditor and as per affidavit dated 06.06.2023 submitted by the Secured Creditor there is no stay declared by any court of law.

And

12) The property is not under lessee / tenancy as per affidavit, deed(s), records or all other relevant documents

And

Therefore, after careful consideration of the contents of the affidavit including the nine clauses mentioned under Section 14(1) B of the Securitisation and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002 and all other relevant documents, which the Secured Creditor filed duly affirmed by the Authorized Officer of Indian Bank (E-Allahabad Bank), Paikpara Branch, 54 Talapark Avenue, Paikpara, Kolkata – 700037 and being satisfied, it is hereby ordered that Smt. Tulika Dutta (Banerjee), Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub-Divisional Officer, Barrackpore Sub-Division, under the District Magistrate, North 24 Parganas will take physical possession of the Secured Asset(s) / Property(s) and forward the same to the Secured Creditor u/s 14 (1A) of SARFAESI Act, 2002.

And

Whereas, Authorized Officer of Indian Bank (E-Allahabad Bank), Paikpara Branch, 54 Talapark Avenue, Paikpara, Kolkata – 700037 shall intimate the date of possession of the Secured Asset to the Commissioner of Police, Barrackpore Police Commissionerate, North 24 Parganas as well as to, Smt. Tulika Dutta (Banerjee), Executive Magistrate by Sub Section (1) of Section 20 of the Criminal Procedure, 1973 (Act 2 of 1974), in the Office of the Sub-Divisional Officer, Barrackpore Sub-Division, under the District Magistrate, North 24 Parganas, well in advance to take physical possession of the Secured Asset(s) / Property(s) of the Secured Creditor on behalf of District Magistrate, North 24 Parganas. The Commissioner of Police, Barrackpore Police Commissionerate, North 24 Parganas will provide Police Force for maintenance of Law & Order. The Secured Creditor will remain present at the time of taking over physical possession.

A spot videography should be made in connection with taking over physical possession of Secured Asset(s) / Property, on the date of taking over possession and soft copy of the videography should be kept under custody.

Let copy of this order be served upon all concerned.

The order is to be enforced within 06 (Six) months from the date of receipt of this order.
